General terms and conditions of sale of Camping Le Perpetuum:

1. Reservation

Any order request placed on the website or by post constitutes the formation of a contract concluded remotely, and necessarily implies acceptance, without restriction or reservation on your part, of these conditions.

The campsite informs its customers that the sale of accommodation services is not subject to the provisions relating to the 14-day withdrawal period applicable to distance selling.

The reservation of a campsite pitch or rental is made on a strictly personal basis. Under no circumstances may you sublet or transfer your reservation without the prior consent of the campsite managers. The campsite cannot under any circumstances guarantee a specific pitch for the chosen accommodation. Only the place, dates and type of accommodation are guaranteed, the campsite will nevertheless do what is necessary to satisfy the camper's request according to availability.

Minors must be accompanied by their parents or legal guardians. Minors are placed under their responsibility. It is strictly forbidden to leave them alone, without supervision, within the campsite. Camping Le Perpetuum reserves the right to refuse access to the campsite to groups or families with more participants than the capacity of the rented accommodation.

2. Visitor's tax and booking fees

The announced amounts of tourist taxes are provisional and are included in the total of the stay when booking online. In the event of an increase in the tourist tax, the Customer shall pay the amount corresponding to the tax in force on the day of arrival at the Campsite.

The booking fee is 15€, to be added to the rates. They are offered for short rental stays (1 to 3 nights) out of season and for all pitch reservations out of season. They are in no way refundable.

3. Cancellation and modification

Cancellation insurance :

We advise you to take out a cancellation insurance, for this, 2 options:

- With the FFCC card (French Federation of Camping and Caravaning) to be taken out directly with them before your reservation or the same day.

Cancellation fees without guarantee :

If your cancellation occurs

- More than 60 days before your stay, the fee is 10% of the total amount of your stay.
- Between the 59th and 30th day before your stay: 50% of the total amount of your stay.
- Between the 29th and the scheduled day of your arrival: 100% of the total amount of your stay.

In all cases, 15€ of expenses will not be refunded. The base of the total amount includes the different options subscribed to and excludes tourist taxes and booking fees.

You can cancel or modify your stay up to 15 days before your arrival, free of charge, for any reason related to the Covid-19*. You will be offered either a voucher valid for 18 months from the date of issue. We will keep a watchful eye on the evolution of the situation and on the recommendations issued by the public and health authorities.

* The campsite must close, your place of residence is confined, border closure due to Covid-19, one of the participants is affected by Covid-19 at the time of departure. If one of the participants has covid-19, you must present us with the results of a PSR test to confirm it.

The campsite cannot be held responsible for the non-fulfilment of the contract concluded, in the event of interruption or unavailability of the stay, in the event of force majeure, disruption or total or partial strike notably of the postal services and means of transport and/or communications, flooding, fire and any other unforeseeable event.

In the event of administrative closure of the campsite, the campsite will offer you a postponement of your stay, a credit note or a refund according to the law in force. If no law is applicable, the campsite will apply its general terms and conditions of sale.

Modification of the initial stay :

For any modification of a stay (date, number of people, type of pitch or rental...), please send us an email with your modifications. The campsite reserves the right to accept or not these modifications, particularly in terms of availability. For any difference in price following a change of stay, the cancellation fee conditions will apply. The modifications only concern the current season. No postponement to the following season will be accepted.

4. Equipment and options

It may happen that certain activities and facilities offered by the campsite and indicated in the description in the catalogue may be cancelled, particularly for climatic reasons or in the event of force majeure, or may not operate in the pre- or off-season.

The vehicles :

Only one vehicle per rental unit or camping pitch is authorised. A supplement for each additional vehicle will be requested (see current price list).

The circulation of motor vehicles is limited to 10km/h and is forbidden in the campsite between 11pm and 7am.

From 11pm onwards, it is compulsory to respect the right to rest of your neighbour.

Visitors :

Visitors, even if invited by campers, are allowed under the responsibility of their host, after reporting their presence at the reception desk and having paid the visitor's rate in force, and they do not have access to the swimming pools. The visitor's rate applies for a maximum of 3 hours. Beyond that, and for any access to the swimming pool as a visitor, the daily camper rate per person applies.

Image :

You authorise Camping Le Perpetuum or any service provider hired by the campsite, to photograph, record or film you during your stay and to use the said images, sounds, videos and recordings on all media (in particular on our website or social networks). This authorisation applies both to you and to the people staying with you. Its sole purpose is to ensure the promotion and animation of the establishments and the network and will not in any way damage your reputation.

All clients and visitors undertake to comply with the provisions of the internal regulations posted at the campsite.

Should these conditions not be complied with by either party, the competent court to deal with this dispute would be that of the Dordogne department.

5. Conditions for mobile home rentals :

The amount of the deposit is equal to 25% of the amount of the stay + 15 euros for booking fees. Upon receipt of the booking form, the campsite will send you a booking confirmation. The balance of the rental will be paid 30 days before arrival for stays from 01/07 to 31/08 (failure to comply with this clause will result in the cancellation of the reservation). For bookings made less than 30 days before the start of the stay, full payment must be made at the time of booking in the village. Except for July and August, the balance of the rent can be paid on the day of arrival.

No early departure or late arrival will be refunded. Any request to reduce the length of your stay is considered as a partial cancellation and will be subject to the terms and conditions of cancellation and interruption of stay.

In July-August, arrivals are from 16:00 and departures before 10:00 on Wednesdays and Saturdays only.

Outside July and August, arrivals and departures are every day.

Access to the accommodation may be refused in the event of disruptive behaviour by guests, contrary to the calm and serenity of the site.

Animals are strictly forbidden inside the mobile homes.

Smoking or steaming is forbidden inside the mobile homes.

Maps and photos of the accommodation are given for illustrative purposes only. The layout and characteristics of the rooms may vary slightly from one model to another.

On the day of your arrival, you will be asked for a deposit of 180 euros. (100 € for the mobile home and 80 € for the cleaning). An inventory of fixtures will be made by the holidaymaker on the day of arrival, any remarks should be reported to the reception on the first day.

The deposit will be returned to you on your departure after an inventory of fixtures by a member of the campsite team, except in the case of damage.

Cleaning is the responsibility of the tenant (unless the holidaymaker has paid for the cleaning fee). At the end of your stay, the rental must be perfectly clean. If not, a financial contribution will be deducted from your deposit. The deduction of the deposit does not exclude additional compensation in the event that the costs are higher than the amount of the deposit. If the tenant wishes to leave during the night, the inventory will be made without his presence and the deposit will be returned the following week by post or bank transfer.

Holidaymakers must bring their own sheets and pillowcases (except if bed linen has been reserved in advance).

An inventory is provided inside each rental property. Rates include gas, electricity and water.

6. Conditions for camping pitches :

The pitch is available on the day of arrival from 3.00 pm and must be vacated on the day of departure before 12.00 pm.

If the pitch is vacated after 12.00 noon, an extra night will be charged.

Payment of the stay : The day before your departure from the campsite.

The number of persons must not exceed 6 persons per pitch.

The campsite cannot guarantee SPECIAL REQUESTS made at the time of a reservation (pitch number or other ...) When you make your reservation, a pitch number is given to you, however this number is not contractual, it will not be communicated to you before your arrival.

The camping pitches share water and electricity points. We cannot guarantee that they will be on your pitch or further away. Please bring an extension of 25m.

Pets :

Pets are allowed on the pitches (except 1st and 2nd category dogs) for an extra charge per night and per animal (see current rates). They must be kept on a lead at all times and their droppings must be collected. Dogs are not allowed near the swimming pools, in food shops or in the buildings. The vaccination booklet for dogs and cats is compulsory and must be up to date. It will be requested upon arrival. Animals must not under any circumstances be left alone on the campsite.

We kindly ask you to inform us of any delays. After 24 hours without any news from you, we will take back the rental and cancel the reservation. The deposit paid will be retained.
